Enclosed is a check or money order for \$50.00, payable to the SFA for the initiation fee (\$10.00) and first year dues (\$40.00). To maintain my membership, I will pay the annual dues of \$40.00 no later than 30 January each year. If paid after 30 January, I must pay an additional \$5.00 reinstatement fee (total of \$45.00). Lifetime membership is available to members in good standing at a cost of \$440.00 (\$475.00 if dues are not current.). All qualified new members must pay a total of \$480.00 for a new Lifetime membership. Age 65 or over, \$360.00 if a new member (cost \$320.00 in good standing/\$345.00 if dues are not current).
